



Did you receive my email response on 5/19/17? If not, I have copied and pasted my responses below:

• We cannot fit a drum container under the Drum that is under the Filter Crusher would it be appropriate to put a 30 gallon Drum inside a 55 gallon drum and be acceptable?

Yes. Placing one drum inside the other would be an acceptable form of secondary containment for the filter crusher.

Also we will be moving the crushed filters outside under the carport sitting on the asphalt with lids on them if this
is also acceptable.

Will you be moving the drums of the drained crushed filters or the actual crusher outside? Is the carport an enclosed area or a covered area (no walls)? Is the ground asphalt, poured concrete, stone, etc.?
