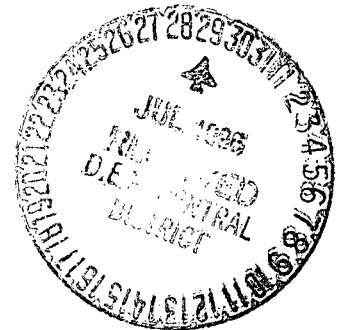

Dear Mr Snyder:

This letter constitutes a response to the First Notice of Deficiency for a Hazardous Facility Waste Permit Application that Chemical Conservation Corporation (CCC) submitted on November 1, 1995. The response addresses comments contained in a letter from the Florida Department of Environmental Protection (DEP) dated January 24, 1996. Submittal of the response was requested in your letter of July 18, 1996, which also requires CCC to publish a public notice announcing the filing of the application.

Attached to this letter is the response which consists of five items: a response summary, a notarized proof of a newspaper publication, one set of the "red-lined" version of the revised permit application pages, four sets of tab dividers and four sets of the permit application revision. The first four items mentioned above are contained in a binder labeled BOOK 1, and the last item is found in the binder labeled BOOK 2. The response summary consists of a six page document that answers questions contained in the comments and explains how the DEP concerns have been addressed in the application revision. The proof of newspaper publication demonstrates that the public notice has been published as required.
