Re: Public Notice Requirements

Dear Mr. Gonzalez:

Chemical Conservation Corporation (CCC) has submitted a permit modification to the Department on November 3, 1995 for the purpose of modifying their present construction permit (HC48-024160).

At the time CCC failed to public notice the modification in accordance with 403.722(12) of the Florida Statutes, which states: "On the same day of filing with the Department of an application for a permit for the construction modification, or operation of a hazardous waste facility, the applicant shall notify each city and county within one mile of the facility of the filing of the application and shall publish notice of the filing of the application. The applicant shall publish a second notice of the filing within 14 days after the date of filing. Each notice shall be published in a newspaper of general circulation in the county of which the facility is located or is proposed to be located. Notwithstanding the provisions of Chapter 50, the purpose of this section, a "newspaper of general circulation" shall be the newspaper within the county in which the installation or facility is proposed which has the largest daily circulation in that county and has the principle office in that county. If the newspaper with the largest daily circulation has its principle office outside the county, the notice shall appear both in the newspaper with the largest daily circulation in that county, and in a newspaper authorized to publish legal notices in that county. The notice shall contain:

- (a) The name of the applicant and a brief description of the project and its location.
- (b) The location of the application file and when it is available for public inspection.

The notice shall be prepared by the applicant and shall comply with the following format:

Notice of Application

The Department of Environmental Protection announces receipt of an application for a permit from (name of applicant) to (brief description of project). This proposed project will be located at (location)(county)(city). This application is being processed and is available for public inspection during normal business hours, 8:00 a.m. to 5:00 p.m., Monday through Friday, except legal holidays, at the Department of Environmental Protection, 3319 Maguire Boulevard, Orlando, Florida 32803.
