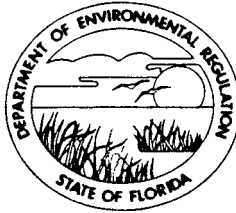

This letter acknowledges the receipt of your application and application processing fee of \$1000 to construct a metal shelter to be used as a hazardous waste facility. The Department's file number for this unit is HC10-128082.

A review of this application revealed that the application is incomplete. You have submitted only the first three pages of the application. Four additional pages are missing or they were not submitted. These pages are enclosed (Enclosure 1); please fill them out and return them to this office.

Moreover, you haven't submitted any information to show how this new unit will comply with Chapter 17-30 Florida Administrative Code or 40 CFR Part 261 and Subpart B to I of Part 264.

Most of the information for Part I (General) of this application will be the same as you have submitted for your application #H0 10-119940. If there is any difference, please let us know and submit that information to us.

Part II (Containers) of the application requires detailed technical information regarding the design and construction of the building. This section also requires detailed information on management of containers and inspection procedures. Also, a closure plan will be required for this unit. You may want to prepare a new closure plan to combine the old and new units as one. We request that you submit everything for Part II, even if you have submitted it as part of another permit. 
The design plans that you have submitted are not signed or sealed by a professional engineer registered in the State of Florida, which is required by the Florida Administrative Code 17-30.220(5).
