The Used Oil Rule requires the automobile and pollution liability, however, according to the ACORD form submitted the Insurance form on file does not match the required Insurance forms needed (see attached). UO transporters are required to provide an Insurance form for the automobile liability inclusive of pollution liability. However, in the event your policies are separate then we will need you to submit two separate Insurance forms.
