HAZARDOUS WASTE
PERMITTING

Re: Transfer Facility Notification for Boynton Beach facility,
FLD 984 167 791 and Medley facility, FLD 984 171 165.

Dear Mr. San Agustin:

The Department has reviewed your February 4, 1992 letter providing notification of intent to use the Boynton Beach and Medley branches as transfer facilities. The Boynton Beach facility may conduct hazardous waste transfer activities. The Medley facility, however, may not conduct transfer activities, at this time.

Information demonstrating that the Boynton Beach facility is in compliance with section 17-730.171 F.A.C., transfer facility requirements, has been submitted. The facility meets the conditions of Hazardous Waste Operating Permit HC 50-195905. In meeting the operating permit conditions the facility has also satisfied 17-730 F.A.C. Transfer Facility requirements.

The Medley facility, to date, has not fulfilled the conditions of Hazardous Waste Construction Permit HC 13- 175466. The permit is currently undergoing modification. Specific Condition number (8) eight of the modified permit will read as follows:

8. The permittee may not commence storage of hazardous waste at the facility until:
 - (a) The permittee has submitted the engineering certification of construction in compliance with the permit application;



- (b) The Department has inspected the newly constructed facility and finds it in compliance with the conditions of the permit, and other applicable state regulations;
- (c) Personnel training has been completed;
- (d) The permittee may, however, as per F.A.C. 17-730.250 (3), operate until final agency action is taken on the operating permit. Storage of hazardous waste may commence only after compliance with Specific Condition 8.(a),(b) and (c), above, has been satisfied.

Prior to conducting transfer facility activities at the Medley facility, Safety-Kleen must be in compliance with Specific Condition (8) eight of the modified permit. The information supplied on DER FORM 17-730.900(6), Transfer Facility Notification Form, will be acceptable once that compliance is achieved and the facility would be granted permission to conduct hazardous waste transfer activities.
