Your permit renewal application and additional information documentation dated August 18, 2017 and December 4, 2017 has been reviewed and found to be substantially complete. The Department has one minor clarification to add regarding your additional information documentation for Comment No. 7c - LES Closure Plan Soil and Groundwater Sampling Protocols. Please note this requirement for future reference and closure plan amendments. Rule 62-780.600(5)(c)1, F.A.C. Site Assessment requires that sampling intervals be collected from land surface to six inches, six inches to two feet, and two-foot intervals thereafter to the extent necessary to define soil contamination. Be advised that more detail regarding proposed sampling locations may be required at the time of closure.

For planning purposes, I intend to send you a courtesy copy of the draft permit for your review and comments no later than January 2018. We will make every effort to issue our final agency action as quickly as possible.
