Duval County – Regulated Storage Tanks

Dear Mr. Turovsky,

A review of your facility by the Northeast District storage tank's section was conducted starting on April 18th, 2018. During this review, potential non-compliance was noted. The purpose of this letter is to offer compliance assistance as a means of resolving this matter.

Specifically, potential non-compliance with the requirements of chapter 376, Florida Statutes and chapter 62-761.300, Florida Administrative Code was observed.

Based on the Department's review of the subject facility permits as well as the facility's file, the following items of concern remain:

- a. Your facility may have regulated storage tanks per 62-761.300 that are currently not registered with the Department. Please register all regulated tanks through the Electronic Self-Service Application Portal (ESSA) http://www.fldepportal.com/go/submit-registration/
- b. An initial inspection of the tanks may also be required, please contact Jean Richards (below) for scheduling of the inspection.

We request you review these specific items of concern noted above and respond in writing within 15 days of receipt of this Compliance Assistance Offer. Your written response should include one of the following:

- 1. Describe what has been done to resolve the non-compliance issues or provide a schedule describing how/when the issues will be addressed.
- 2. Provide information that either mitigates the concerns or demonstrates them to be invalid, or
- 3. Arrange for one of our inspectors to visit your facility to discuss the items of concern.

It is the Department's desire that you are able adequately to address the aforementioned issue so that this matter can be closed. Your failure to respond promptly may result in the initiation of formal enforcement proceedings.
