They are a TSD and have a Part B permit for storage and treatment on-site. We just inspected them a month ago. This site assessment referred to in the email is related to a fire at the facility in January 2017. The water run-off from the firefighting reached a storm drain and flowed into a dirt swale on-site. Initial sampling of the swale indicated a release so contamination assessment was req'd.

Don had sent the initial sampling results to Missy (copy Julie) back in January and Missy made recommendations for additional sampling req'ts related to the discharge. Carrie Kruchell is the permit POC in Tally and she's probably aware of this but I'll pass this on to her to make sure.
