The Department has reviewed and conditionally approves the referenced document based on the following

1. The facility must include documentation that any cracks and/or gaps in the floor and walls are free of mercury. This can be accomplished by verifying there are no cracks or gaps in the flooring or walls. Photographic documentation, before and after the task completion, should be provided. Please acknowledge your acceptance of this condition by July 31, 2018. An eMail response is acceptable.

Please provide notification to the Hazardous Waste Program and Permitting Section in Tallahassee and to the Central District prior to implementation of closure activities.

The Department recommends a pre-application meeting or conference call be scheduled to discuss the permit modification noted in the plan prior to submittal to the Department.
