

Used Oil Application


- The 8700-12 lists the address as 3555 E SR 60 (Please note that if this is the correct address, an updated 8700-12 should be resubmitted using the revised form version dated April 23, 2013).
- Form 62-710.901(6), Part II, PE Certification: address listed as 3055 E SR 60 (please revise).
- Cover page of SPCC: address listed as 3555 E SR 60.
- SPCC PE Certification: address listed as 508Q E SR 60.
- Closing Cost Estimate Form: address listed as 508Q E SR 60.

Solid Waste Application


- Application: address listed as 508Q E SR 60.
- Closure Plan Introduction: address listed as 508Q E SR 60.
