Answers below:

- 1. On the COC, there are several different dates that appear related to dates of container shipping, sample collection, and lab sampling. Please explain the timeline and process for collecting this sample. Kevin Falls collected a one quart representative sample on 7/23/18 at 800 AM EST at HCC Jacksonville, FL branch. The sample contained branch non-hazardous oily waste (i.e. gloves, absorbent pads, etc). The sample was put into a larger 1-2 gallon container on ice with four zip ties and mailed overnight to the Pace New Orleans lab which was received 7/24/18.
- 2. Please explain the relationship between Pace Indianapolis and Pace New Orleans. The latter Pace is the Florida registered NELAP lab, yet the final report is provided on Pace Indianapolis letterhead and signed by the lab manager in Indianapolis. Pace Indy does the reporting but Pace New Orleans did the analysis. The report shown is a short report and can be modified to include more information.
- 3. The COC is difficult to read please provide the name of the sampler and the person that received the sample in New Orleans. Kevin Falls was the sampler. Jerry Miller is the person that received the sample in Pace New Orleans.
- 4. Please provide the type of training that the sampler has obtained and the date it was given. Kevin Falls received training from Don Pennell, (Manager, Field Regulatory Compliance and Sales Training) on how to collect samples. See attached training certificate and sampling supplies and sampling procedures covered in the course.
- 5. On the COC, I did note that in the "Sample Conditions" section the lab noted that the temp was 26.5°C which is unacceptable for performing this test method and does not meet Florida Guidelines for Field Sampling or QA. Please explain your protocol for situations where this occurs. The sample was sent with blue ice that did not cool the sample down to the required <6 degrees C temperature. We understand the sampling did not meet the FL requirements for temperature, but we don't believe the outcome would be different.

Vinnie – I believe the only items we need clarification/information on are listed below.

- 1. Used Oil (UO) and Used Oil Filter (UOF) log or equivalent information (DEP form previously sent) [reg 40 CFR 279.46; 62-710.510(1), Florida Administrative Code (FAC)]; HCC track used oil and used oil filter log in CCMS (Crystal Clean Management System) program. Cheryl, if you need some data on this, I will need Anita to give me some help in CCMS.
- 2. How is HCC's waste stream "Branch Debris" managed/treated? [40 CFR 279.47]

 Branch debris (gloves, oil pads, absorbent, etc.) goes in a 55-gallon drum as non-hazardous waste and is shipped to the Atlanta hub, which will then be sent to a TSDF.
- 3. Contingency Plan and arrangements made with local emergency response authorities [40 CFR 265.50-.56] In 2015 we submitted contingency plan to local emergency response agencies, but the agencies did not submit arrangement back to us. Attached are those submissions and

our current contingency plan that was submitted with the 2017 CY tier II reports online to the FL tier II website for emergency responders. Attached are those submissions and our current contingency plan that was submitted with the tier II reports online to the FL tier II website for emergency responders.

- 4. Do the labs that HCC uses for waste sampling have NELAP/DOH certification by State of Florida? [62-160.300, FAC] We have used Pace in New Orleans with the FL certification.
- 5. How is VSQG waste managed after it arrives in Atlanta? The HCC Atlanta hub operates also as a 10-day hazardous waste transfer facility. Any hazardous waste drums are re-organized depending on the waste type and then shipped to a Treatment, Storage, and Disposal Facility (TSDF).
