Thank you for your application for an operation permit minor modification for the above referenced Facility. The Department has assigned DEP Application No. 64247-019-SO/MM to the application. A Department staff review of the application and supporting documentation submitted on August 31, 2018, indicates the application is incomplete. Pursuant to the provisions of Rule 62-4.055, F.A.C., please provide the information listed below and refer to this correspondence in your response. The response to this correspondence must be signed, sealed, and dated by a registered Florida Professional Engineer.

- 1. **Enclosure 1.** Application form 62-701.900(4) Item A.5. lists the facility WACS identification number incorrectly. The correct facility WACS identification number is 101281. Please revise this item.
- 2. **Enclosure 3.** Drawing 64BW-5600-604 signed and sealed 08/28/18 and referred to as Figure F-1.9b, shows the configuration of the shredder, ramp and the related loading platform in Section A-A. Please revise this drawing and specifically this section to provide details of the orientation of shredder operations when located inside the former media storage building as proposed in this application.
- 3. **Enclosure 3.** Chapter I Appendix C proposes Diaper Dust as an additional solidification media for use in solid waste processing. Part II Subpart B5 item 2.b. of permit number 64247-018-SO defines solidification media as materials which may change the physical characteristics (e.g. solid/liquid state), but not the chemical characteristics of the materials. Please provide additional information which verifies that Diaper Dust meets this definition.

4. **Enclosure 4.** While most revisions to the permit documents submitted with this application remove reference to the SSI Model M85 shredder, the revisions to Attachment B did not eliminate a specification sheet referencing this M85 model. The specification sheet is listed as Page 4 of 22 in the version of Attachment B which shows revisions made. Please verify that that model shredder is not proposed for use and revise this attachment to remain consistent with other portions of this application

In order for the Department to continue processing your application, please submit the requested information as soon as possible. The Department requests a response within 60 days of the date of this letter, November 4, 2018, unless a written request for additional time to provide the requested information is submitted and approved Pursuant to Rule 62-4.055(1), F.A.C. and Section 120.60, F.S., failure of an applicant to provide the timely requested information by the applicable deadline [90 days from the date of this letter] may result in denial of the application, unless a written request for additional time to provide the requested information is submitted and approved. You are encouraged to contact this office to discuss the items requested to assist you in developing a complete and adequate response.
