**Introduction:**

On January 9, 2019, Michael Eckoff, Florida Department of Environmental Protection, inspected Grace Trucking LLC for compliance with state and federal hazardous waste transporter requirements. No one was available at 9330 Meadow Creek Ln, Clermont, to assist the inspector. The facility most recently notified the Department of its waste activities on August 12, 2018 and was initially issued EPA ID FLR000201103 on July 30, 2013.

The facility is registered as a hazardous waste transporter and a used oil transporter. Both registrations expire June 30, 2019.

**INSPECTION HISTORY**

The facility was inspected in February 2014 for compliance with state and federal hazardous waste transporter requirements and no potential violations were noted at that time.

**Process Description:**

In a phone conversation with John Blankenship on January 23, 2019, he explained the only material his company hauls is on-specification oil. He stated the oil is picked up from Petrotech SE and delivered to a facility in Alabama. Mr. Blankenship was asked to provide copies of hauling tickets.

In an email dated January 24, 2019, Rachel Blankenship provided copies of hauling tickets. The copies indicate Grace Trucking LLC hauls on-specification oil from Petrotech SE to Vertex Energy/ARC Terminals/Chickasaw Terminal in Alabama.
