This letter is to inform you that effective immediately you are no longer authorized to transport, or market used oil, or used oil filters, or burn off-specification used oil, in the State of Florida under this EPA ID number. Handling used oil or used oil filters without a valid registration is a violation of the law, subject to penalty.

In an effort to provide a more efficient service, the Florida Department of Environmental Protection's Permitting and Compliance Assistance Program Authorization Representative is forwarding the attached document(s) to you by electronic correspondence in lieu of a hard copy through the normal postal service.
