Beth – please see attached. I'm not familiar with ER Contractor rates. It's not our fault that we are engaged in business that pays more both to the employee & our company providing our marine industry services. Nevertheless, I have reduced our per hour labor fee from \$40.00 to \$35.00. I additionally lowered our PPE expense from \$50.00 per tech to \$40.00 per tech.
