The Department has previously discussed some of the issues you raise, such as additional site assessment and monitoring, with Eglin representatives. I'm sure that you recognize the inherent difficulties and safety issues associated with environmental assessment on active bombing ranges.

As you are probably aware, Eglin Air Force Base has submitted a renewal permit application for the continued operation of their Open Burn/Open Detonation units.
