In response to DEPs inspection conducted on 20 December 2018 the following violations have been corrected.

1. Containers established for used oil, used antifreeze and oil filters were not properly labeled.

Corrective Action: Containers are not marked and stenciled with the proper contents of the drums. (Please see pictures attached.)

2. Proper disposal of used fluorescent bulbs.

Corrective Action: All shop and office personnel have been trained on the proper packaging and disposal of used fluorescent bulbs. Used bulbs will be placed in the packaging of the new purchased bulbs and stored in an area where the bulbs are not at risk of being broken. Once there is a sufficient amount of bulbs accumulated, they will be turned in to the Batteries Plus Bulbs in Pace, Fl.
