Introduction:

On June 17, 2020, John White, Florida Department of Environmental Protection, inspected Aptim Environmental & Infrastructure for compliance with state and federal hazardous waste transporter requirements. Aptim Environmental & Infrastructure was represented by Shawn Flynn, Project Manager. The office was undergoing renovations and very few employees were working on-site.

Aptim Environmental & Infrastructure was last inspected on December 7, 2016 as a hazardous waste transporter and no violations were identified at that time.

Process Description:

The facility does not actively transport hazardous waste. Based on the requirements of each specific job, transportation of hazardous waste will be subcontracted to a registered hazardous waste transporter.

Due to construction activities, the warehouse was not inspected. During past inspections, the warehouse was used only for storage of supplies and equipment.

A review of insurance and required registrations found no issues. Aptim Environmental & Infrastructure most recently provided the required proof of liability insurance as a hazardous waste transporter on July 2, 2019. The facilities registration as a hazardous waste transporter is current through June 30, 2020.

Conclusion:

Aptim Environmental & Infrastructure was inspected as a transporter of hazardous waste and no potential violations were found at this time.
