RE:	Informal Meeting to Discuss Warning Letter Issued August 12, 2019

This was an informal conference to discuss the DEP Warning Letter issued on August 12, 2019, to FedEx Ground Package System (FedEx Ground). The Agenda included the following:

The meeting began with Aaron Watkins having all attendees introduce themselves. Mr. Watkins then proceeded to discuss the Department's interpretation of the regulations and

corrective actions. Mr. Watkins did acknowledge FedEx Ground Package System has a different interpretation. Mr. Watkins indicated that it was his position that we apply the rules as we understand them and have a judge say we did not apply the rule correctly.

FedEx Ground's Senior Counsel, Jamie Spataro, provided a letter from the U.S. Department of Transportation dated October 24, 2018, that he indicated provides FedEx Ground's position. The Department had not been provided with a copy of the document prior to this meeting.

Gaylyn Frosini discussed some specific violations outlined in the Warning Letter. It was FedEx Ground's position that the Ocala hub was not a large quantity generator of hazardous waste. They believe the transporter did not correctly weigh the hazardous waste shipments. Also, due to lab packs for waste shipments, the company was having difficulty matching up waste codes to reply to the Department's concerns of overuse of F codes versus U codes for waste. Regardless, the Ocala facility has re-notified as a large quantity generator (LQG) and meets the requirements for a LQG.

Mr. Spataro indicated EPA Region 6 is aware of FedEx Ground's practices as well as North Carolina and neither party has taken any action.

Ron Hoenstine asked if FedEx Ground has contacted EPA regarding the transportation issues and the reply was they have not.
