The application shall meet the fee requirements of Rule 62-4.050 and Rule 62-730.293, F.A.C. The Permittee shall submit a copy of the cover letter accompanying the permit applications and the fees to:

Florida Department of Environmental Protection  
Hazardous Waste Program and Permitting  
Post Office Box 3070, Tallahassee, Florida 32315-3070

The renewal fees may also be submitted electronically. However, if the Permittee intends to submit the renewal fees electronically, the Permittee shall obtain instructions from the Department on how to submit the renewal fees electronically prior to attempting such submittal and shall follow such instructions in making the electronic fee submittal.

DEP held a brief pre-application teleconference with Clean Harbors and Safety-Kleen representatives on February 22, 2021. During that discussion, it was noted that there are no facility operating or solid waste permit changes planned for the Clean Harbors facility. However, in order for the Department to conduct a complete review, the Department requires that complete permit applications, as opposed to short form permit renewal applications, be submitted by June 13, 2021.
