In a meeting earlier regarding review of the draft S-K Orange Park Permit Mod, we briefly discussed the fact that Clean Harbors currently stores and transports Waste Pharmaceuticals at its facility in Bartow.

Even though it was thought there would be no changes to the Operating side of the permit for Clean Harbors (see attached letter), it seems we need to add the Waste Pharms service line and HW management details into the renewal permit given the new EPA regs that came out for Waste Pharms.

Jeff and I thought we could do the Orange Park Mod first, and then work on adding this service line to both renewal permit applications for S-K TPA and Clean Harbors.

As I told Jeff this morning, I'm going to start developing a new "checklist" for Waste Pharms that we can add to our RCRA Permit Application Checklist, which will hopefully make it easier for all of us going forward.

I'll arrange another teleconference with all in the coming weeks.
