Hey Robert – as for the Contingency and Closure Plans, Jason reached out to me this week on those and I'll keep you copied on my response.

As for the inspection information, there were a few record-keeping issues we discussed on 2/18 that I would like to see copies of the new forms you all are/will be using for the following: 1) weekly inspections for just the HW containers in the transfer facility area (instead of the one you used for the entire facility); and 2) a log for the incoming HW containers that included manifest #s for each container, quantity in each container, arrival and departure dates. For the latter, there are other req'ts under our 62-730.171, FAC, related to those logs that require each generator be ID on the log but because there are multiple generators for each container, I believe that req't can be met using the hard copies of the manifests you all attached to the shipping documents.

Episodic event for paint waste: please provide a copy of the return manifest (signed at the bottom by the receiving facility).

Training records: I initially thought you had attended our 2020 Transporter workshop in Feb 2020 but I didn't find your name (or any Crowley rep) on the final attendance list so I will need documentation that you recv'd HW training after you assumed the EHS duties at Crowley in 2019.

And that should be all I need to complete the report. As we discussed, there will be 'open' violations related to the Plans (and possibly the records above) but those can be completed under our Compliance Assistance Offer that we send you with the inspection report.
