Thank you for your application for a Used Oil & Material Processing Permit Renewal for the above referenced Facility. A Department staff review of the application submitted on February 22, 2022, indicates the application is incomplete. Pursuant to the provisions of Rule 62-710.800(3), Florida Administrative Code (F.A.C.) and Chapter 403.722, Florida Statutes (F.S.), all processing of the application is suspended when a permit application is deemed incomplete. - 8. Please provide C.B.I. Inc. Port Everglades Facility Tank Farm Revised Site Plan Map with 8.5"X11" in Word document, so that the map can be easily inserted into the renewal draft permit.
- 9. Please provide a tank table with all the information (Refer the Existing Permit, Page 30) with 8.5"X11" in Word document, so that this can be easily inserted into the renewal draft permit.
- 10. Any additional comments from the Southeast District Office, we will forward to you ASAP.

In order for the Department to continue processing your application, please submit the information requested as soon as possible, and refer to this correspondence in your response. The response must be signed, sealed, and dated by a registered Florida Professional Engineer. The Department must receive a response within 30 days of the date of this letter, or April 7, 2022 unless a written request for additional time to provide the requested information is submitted and approved. Pursuant to subsection 62-730.220(6), F.A.C. and Section 120.60, F.S., failure of an applicant to provide the timely requested information by the applicable deadline may result in
