Good afternoon everyone,

Just wanted to try and clarify better the circumstances that generated this unmanifested waste report. Safety-Kleen has been servicing a small parts washer at Corteva Agriscience for several years. The parts washer generates approximately 12 gallons (~80.4 lbs.) of spent solvent per service, and carries the D039 waste code. In Safety-Kleen's system the account was set up with generator status of VSQG/CESQG. During this time, Safety-Kleen was not aware the facility (Corteva) generated additional hazardous waste streams nor that they were a LQG. Corteva had not communicated that information with us, and our service representative was also not aware.

Recently, the Safety-Kleen account manager managing Corteva's account visited the facility in person to discuss the possibility of acquiring additional lines of business. During that site visit and discussion, it was brought to his attention that Corteva was generating additional hazardous waste streams and also was a LQG. This additional hazardous waste was, and is, being managed by a different hazardous waste transporter/company than Safety-Kleen. Our account manager looked up the parts washer services we were performing at Corteva when he returned to the SK branch and noticed that the services were not being completed using an uniform hazardous waste manifest. At this time he contacted myself and I subsequently prepared the report.

The Corteva account generator status has been updated to LQG in our system, which will flag the parts washer service to include a hazardous waste manifest when being performed in the future.
