The District Support Program (DSP) has reviewed the 2023 Annual Groundwater Monitoring Report (dated October 20, 2023), submitted by Geosyntec Consultants (Geosyntec) for Former Davco Printed Circuits Facility (site). The subject document and other related site information were reviewed, and the following review comments are provided to assist the Southeast District staff with their review of this report. DSP's review comments should not be inferred to be an approval of the subject documents or proposals.

During a March 2023 sampling event, the groundwater cleanup target levels (GCTLs) for trichloroethene (TCE) and fluoride were exceeded in the shallow zone. The GCTLs for vinyl chloride (VC) and fluoride were exceeded in the intermediate zone. The GCTLs for cis-1,2-dichloroethene (cDCE), trans-1,2-dichloroethene (tDCE), and VC were exceeded in the deep zone. No other analytes were present above their respective GCTLs.

Based upon the above, I offer the following comment:

 DSP concurs with the recommendation to conduct an additional monitoring event during the 2023 semiannual event at MW-62E to investigate if the natural attenuation monitoring/ post active remediation monitoring (NAM/PARM) action level continues to be exceeded.
