**Introduction:**

On August 23, 2022, Miranda Rothenberger and Gina Laddick, Florida Department of Environmental Protection (FDEP or Department) attempted to inspect All Florida Medial Waste (Facility) for compliance with state and federal hazardous waste and hazardous waste transporter requirements. The facility is located at 1578 Pine Ave, Holly Hill. No one was present to allow access to the facility.

All Florida Medical Waste is a registered hazardous waste transporter under EPA identification number FLR000236513. Registration was renewed on February 28, 2022, and expires on November 30, 2022.

The Department contacted Daniel Gallagher, Owner, via email on August 26, 2022, to confirm the status of the facility. On September 6, 2022, Mr. Gallagher stated that no hazardous waste transportation activities have occurred to date.

**Conclusion:**

The Department conducted records review of All Florida Medical Waste and an attempted-on site inspection on August 23, 2022. As a result of these actions the Department finds the facility to be in compliance.
