Universal Orlando initiated a shipment of hazardous waste on 12/14/2022 using attached copy of manifest 017727139FLE. Universal Orlando will not receive a copy of the manifest with a handwritten signature from the destination facility within forty-five (45) days. This exception report is being provided in accordance with 40 CFR 262.42.

Universal Orlando initially inquired to the transporter and final destination facility as to the location of the waste on Wednesday, January 11, 2023. Our latest inquiry on January 27, 2023 is when our Transporter advised Universal Orlando of the delay. Unfortunately, the Covid-19 pandemic has continued to materially impact staffing levels in all areas of the waste disposal industry. The reduced availability of drivers and facility personnel since the start of the pandemic has created an industry-wide backlog, particularly of containerized waste that requires significant handling. The result is that our shipment related to the attached manifest has been delayed. The waste remains in transit to the destination facility and is being carefully monitored and managed by the transporter. We expect that the shipment will be delivered to the destination facility in the near future.
