1.3 million cubic yards of beach compatible material placed along 1.6 miles of shoreline. The primary sand source will be portions of Big Sarasota Pass and ebb shoal, split over three cuts (B, C and D). Two rubble mound groins will also be constructed at the south end of Lido Key. This

permit also authorizes periodic nourishment events.
