## MONTHLY SUMMARY

From October 1, 1995 to October 31, 1995

1. Tonnage In: 1,735.58

6. Removal and Reconfiguration of Stored Materials:

Work has been completed collecting and stacking all whole tires from the interim storage area and cleaning shreds from the fire lanes as required by the draft Stipulation of Settlement and Request for Consent Final Judgement agreed upon by FDEP and FTR.

5. Fire Fighting Equipment and Training:

a. During the month, FTR continued its practice of starting and running each of the fire trucks in its fire battalion and generally checking the condition of the fire equipment.

6. Trust Fund:

a. A \$4,000 deposit was made the Trust Fund established for financial assurance on July 13, 1995. As of July 31, 1995 the balance was \$126,000 including interest.

7. Engineering and Permit Applications:

a. FTR delivered its application for an amended MSSW permit to FDEP on June 2, 1995. The permit modification was received on July 21, 1995.

b. FTR is awaiting approval from St. Lucie county on the application for an amended site plan. Approval of the site plan is required before submission for the county storm water management permit. Despite this requirement, FTR opted to file for its county permit without having first obtained site plan approval.

8. Other:

a. On July 1, 1995, FTR was advised by Chambers Development that they would no longer be using tire shreds for interim cover. The cut off was effective immediately.

b. 100% of the waste tires collected are being processed into TDF for future shipment to fuel users.

c. After close of the reporting period, FTR's primary fuel account notified the company that it was designating FTR to be its sole source for TDF and ordered an increase in deliveries to 2,400 tons per month.

d. FTR's second fuel account is receiving at a rate of 470 tons per month. Ash problems have delayed planned volume increases. The ash handling system is now being retrofitted to facilitate higher TDF consumption. The capital allocation has been made for the new system and engineering completed. Installation will be made in December.

e. FTR began shipping a third TDF account in the month of October. The account has placed advance orders for delivery of 2,000 tons per month for November and December, 1,500 tons in January and 1,000 tons per month thereafter.
