Dear Ms. Madden:

The following items are submitted in response to the on-site inspection at the Central County Solid Waste Disposal Complex (CCSWDC) for June 2, 2010:

***2.6 – Department staff observed shredded tires being used for sediment control/drainage material in the temporary leachate infiltration area located adjacent to the access road on top of Cell 5. Many of the tires appeared larger (quarter's and halves) than the acceptable size for disposal in a landfill. Facility indicated that the infiltration area would typically be covered with waste once filling operations moved to that location and the tires would be removed.***

The County and the County's contractor will adhere to rule 62-711 specifications when it is determined that tires will be disposed of into the landfill.

***4.24 – An area on the southeast side of the tipping floor (and loading ramp) appeared damaged. A depression in the concrete was observed which may be capable of holding water and prevent proper drainage to the leachate collection system.***

The County's contractor is currently in the process of obtaining bids to fix the tipping floor and loading ramp area. It is anticipated that the repair will be completed by August 1, 2010. When the repair is complete, the County will provide documentation to the department. See letter from WCA Waste Corporation dated June 29, 2010.

***Comments Section – Compressor blow-off was observed around the base of the air compressor unit. Operator indicated that County intends to manage the liquids to prevent them from discharging on the ground around the compressor. Please provide addition information.***

Compressor blow-off water is captured into a collection container and emptied on an as needed basis into the leachate collection system for treatment at a permitted wastewater treatment facility (see photo #1).

***Comments Section – Item 2.28 – The eastern portion of the WF interceptor berm appeared inconsistent and low in some areas.***

The County's contractor shall maintain consistent interceptor berms that are a minimum of three feet in height.

***Comments Section – Item 4.10 – Department staff observed sediment build-up on the MRF floor which had slowed the flow of leachate to the N drains. Also, the truck load out appeared to contain standing leachate and should be pumped out.***

The leachate collection system, which includes the MRF floor and truck load out area shall be maintained on a weekly basis as noted in the MRF Operating and Maintenance Manual dated August 24, 2009. If conditions exist that could potentially violate permit conditions, then maintenance activities shall be conducted on a more frequent basis.

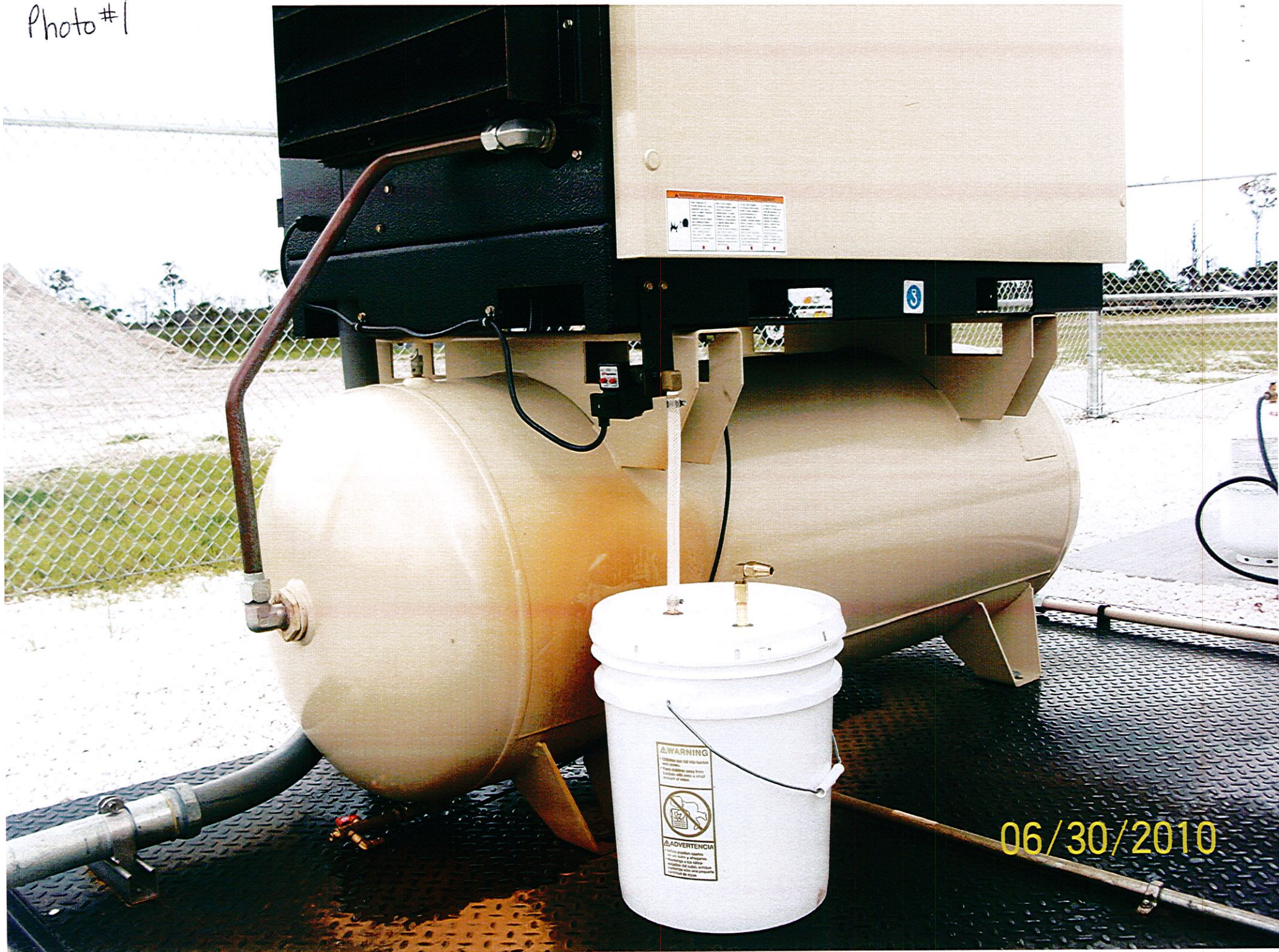
