
RE: Notice of Reinspection and Land Survey of Property & Site

Dear Mr. Quarterson:

This letter will serve as confirmation of a telephone conversation between Mr. Joseph Lurix of this office and you on September 7th concerning the above. As stated to you, it is the Department's intention to conduct a reinspection of the Florida Tire site in accordance with Item I of the Stipulation on September 26th through the 28th for compliance with the terms of the Stipulation. This inspection will include a survey of the site performed by a local registered professional land surveyor at the Department's expense. The purpose of the survey is to determine compliance with Item 10.D.5. of the Stipulation, and to allow the Department to estimate the amount of waste tires stored onsite presently. It appears from your response letter dated August 29th, that the cost of this survey is expensive and that FTRI does not want to bear this expense.

When completed, the results of the survey and reinspection are a public record and will be available for your review. If you have any questions, please contact me at 407/433-2650.

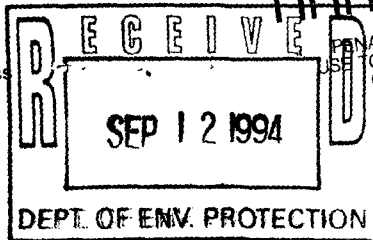
