Determine possible usage of tire chips as initial cover at permitted landfills

Observation confirmed that the processed tire chips were cut into sufficiently small pieces to to be used as initial landfill cover in accordance with F.A.C. Rule 62-711.400(3)(a); 70% cut into pieces 4 square inches or less and 100% cut into pieces 32 square inches or less. It was also noted that tire chips within the processed on-site tire pile interlocked to form a slope much steeper than that required at a landfill; slope no greater than a 3 feet horizontal to a 1 foot vertical rise. Please see picture.

Waste tire chips are approved for initial cover. Any chips observed that are too large to meet the requirements of F.A.C. Rule 62-711.400(3)(a) should be removed by the landfill operator for disposal or additional processing.
