Your application for permit, DEP File Number SO49-0199726-022, is considered complete. The original permit application was dated November 10, 2011 and received by the Department on November 14, 2011. The final information making the permit application complete was dated April 3, 2012 and received by the Department April 4, 2012. The Department will make a final determination about the permit application no later than July 3, 2012.

The Department has reviewed the document "Response to Second Request for Additional Information dated 5 March 2012" for the J.E.D. Solid Waste Management Facility dated April 3, 2012. The document was signed by Victor M. Damasceno, Ph.D., P.E., of Geosyntec Consultants. The Closure Cost Estimating Form for Solid Waste Facilities, DEP Form 62-701.900(28), was included. The closure cost is estimated at \$9,541,740.31. The long-term care cost estimate for 30 years is estimated at \$9,099,143.79. The estimates are approved.
