The purpose of this inspection was to observe site conditions after Tropical Storms (TS) Beryl and Debby (May 28-29 & June 23-26, 2012 respectively). The Department received notification beginning June 1, 2012 from Mr. Casey Stephens, Solid Waste Director for Citrus County, that significant stormwater had accumulated in the Phase 3 sump area. The water had inundated two separate working face/stormwater diversion berms and the inter-cell berm between Phases 2A and 3. The County has estimated upwards of 9,000,000 gallons of stormwater/leachate were present after TS Debby. On July 5, 2012, the County provided analytical results of the water, and requested emergency authorization to discharge the water to the stormwater management system. The Department conditionally approved this request via email on July 9, 2012. Please refer to the Department's correspondence for additional information.

Seepage of stormwater/leachate from Phase 1 into the adjacent swale and subsequently DRA 5 was noted during the June 29, 2012 inspection. The facility indicated repairs to these ares would be scheduled as soon as possible.
