1. In the Rayan Used Tire Wholesale Facility Operation document, under Emergency Contacts please add the following:

2. The Department understands that the maximum amount of tires you wish to store on-site at any one time is 20,000 tires. Please provide a quote from a reputable third party for the cost of loading, hauling and disposal of 20,000 tires.

Once the Department has received and approved this cost estimate, you will need to secure a bond for that amount. This needs to be coordinated with our Tallahassee office. Financial responsibility arrangements for the facility for the approved amount are to be made with the Financial Coordinator, Solid Waste Section, MS-4565, 2600 Blair Stone Road, Tallahassee, Florida 32399-2400, solid.waste.coordinator@dep.state.fl.us.
