#### Cell 3 Construction Certification:

The Certification of Construction Completion Report for Cell 3 was received on November 19, 2012. This inspection reviewed the construction completion for Cell 3. Previous inspections on September 24 and 27 were conducted as construction progressed in Cell 3. At the time of this inspection, construction of Cell 3 was complete. The leachate collection system was flushed and turned on. The sand protective layer was in place and mounded over the sump location to add a layer of protection. Select waste for Cell 3 start-up was discussed.
