This is to acknowledge receipt of the additional information dated March 27, 2013 (received March 28, 2013) provided in support of your permit application to operate and close an alternate fuel/materials processing facility at the CEMEX South Cement Plant, located at 10311 Cement Plant Road, Brooksville, Hernando County, Florida.

This letter constitutes notice that a permit will be required for your project pursuant to Chapter(s) 403, Florida Statutes.

Your application for a permit is <u>incomplete</u>. This is the Department's <u>second</u> request for information. Please provide the information listed below promptly. Evaluation of your proposed project will be delayed until all requested information has been received.

### GENERAL:

- 1. The requested information and comments below do not necessarily repeat the information submitted by the applicant. However, every effort has been made to concisely refer to the section, page, drawing detail number, etc. where the information has been presented in the original submittal.
- 2. Please submit <u>2 copies</u> of all requested information (1 paper, 1 electronic). Please specify if revised information is intended to supplement, or replace, previously submitted information. Please submit all revised plans and reports as a <u>complete package</u>. For revisions to the narrative reports, deletions may be struckthrough (<u>struckthrough</u>) and additions may be underlined (<u>underlined</u>) or similar notation method. This format will expedite the review process. <u>Please include revision date on all revised</u> pages.
- 3. Please provide a summary of all revisions to drawings, and indicate the revision on each of the applicable plan sheets. Please use a consistent numbering system for drawings. Engineering Report (Rules 62-701.320(7)(d) and 62-701.710(2) & (3), F.A.C.: Please provide a revised Engineering Report which includes the information listed below.

### 1. March 27, 2013 Response Letter to Department's December 13, 2012 RAI Letter:

- a. Response to Comments #5.b. & 5.c.:
  - 1) Comments 5.b. & 5.c. of FDEP's December 13<sup>th</sup> letter requested that Section 3.4 of the Engineering Report be revised as appropriate to address the comments. While the information provided in the response letter adequately describes the construction of the A-Frame Building and ASB Building floors, revisions to Section 3.4 of the Engineering Report do not appear to have been provided. Please revise Section 3.4 of the Engineering Report, as appropriate.
  - 2) As described in the March  $27^{\rm th}$  letter and indicated in the information provided in Attachments 4 and 5, the A-frame and ASB buildings both have limerock and/or clay soil floors. These floor types typically wear and/or are damaged over time by the equipment described in Section 3.9.2. of the Engineering Report for material processing and transport (i.e. front end loader and transport trucks & trailers). Please revise an appropriate section of the Engineering Report to describe the facility procedures for maintenance and repair of the floor in these buildings.
- b. Response to Comment #7: While the response provided in the March  $27^{\text{th}}$  letter to Comment #7 is adequate, revisions to Section 3.8 of the Engineering Report do not appear to have been provided. Please provide a revised Section 3.8 of the Engineering Report, consistent with the information provided in the March  $27^{\text{th}}$  response letter.
- c. Response to Comment #8: Please revise the Table of Contents and Section 3.9 of the Engineering Report to reference the Contingency Plan submitted with the March 28, 2013 submittal.
- d. Response to Comment #9: In response to Comment #9, a stand-alone Closure Plan and attachments were submitted with the March 28, 2013 submittal, in lieu of revisions to Section 3.10 and Attachments A-C of the Engineering Report. Please revise the Table of Contents and Section 3.10 of the Engineering Report to reference the submitted Closure Plan.
- e. Response to Comment #10: Rule 62-701.320(8)(a), F.A.C. specifies that a notice of application shall be published within 14 days of submittal of the application. Therefore publication of the notice once the remainder of the application is deemed complete, as described in your response, is not appropriate. Please publish the attached Notice of Application and provide proof of publication to the Department.

### 2. Attachment 4 - A-Frame Permeability and Boring Report:

- a. The description of the vertical permeability testing conducted appears to indicate that ASTM Test Method D6391-06 "Standard Test Method for Field Measurement of Hydraulic Conductivity Limits of Porous Materials Using Two Stages of Infiltration from a Borehole" was utilized. Please verify that this ASTM test method was utilized or identify the alternative test method used and provide a copy of that test method.
- b. A review of ASTM Method D6391-06 appears to indicate that for the vertical permeability portion of the test (Stage 1) the minimum test duration is 12 hours. In the event that this test method was utilized, please provide supporting justification for running the test for only 30 minutes, as describe in Attachment 4.

### 3. Attachment 5 - ASB Building Drawings:

- a. The drawings provided in Attachment 5 do not appear to be asbuilt drawings. Please either provide as-built drawings or provide verification that they are representative of as-built conditions.
- b. Please verify whether hydraulic conductivity information on the installed clay layer is available and provide this information as applicable. In the absence of this information and taking in consideration the typical wear and damage to clay floors described in Comment #1.a.(2) above, please provide supporting justification for assuming that the floor in the ASB building is comparable to the A-Frame building floor and that representative borings of the floor and vertical permeability testing was not necessary to demonstrate the existing floor is as constructed and impermeable.

### 4. Attachment 4 - Closure Plan:

a. Attachment C: The closure cost estimates provided in Attachment C (total for closure \$315,688.32) are acceptable. However Form 62-701.900(28) must be signed and sealed by the engineer of record that prepared the estimate. Please provide a signed and sealed copy of the form. A copy of this letter is forwarded to Financial Coordinator, Solid Waste Section, FDEP, 2600 Blair Stone Road, MS 4565, Tallahassee, Florida 32399-2400. The applicant may work with him directly to assess the facility's compliance with the funding mechanism requirements of Rule 62-701.630, F.A.C. pending receipt of the signed and sealed form and final approval of the cost estimate.

Please respond by June 12, 2013, responding to all of the information requests and indicating when a response to any unanswered questions will be submitted. If the response will require longer than the date noted above, you should develop an alternate specific timetable for the submission of the requested information for Department review and consideration. Pursuant to the provisions of Rule 62-4.055(1), F.A.C., if the Department does not receive a timely, complete response to this request for information the Department may issue a final order denying your application. A denial for lack of information or response will be unbiased as to the merits of the application. The applicant may reapply as soon as the requested information is available.
