Volusia County – SW WACS # 27540 Tomoka Farms Road Landfill North Cell Landfill LGCS Construction for Closure – Sequence 1A **Approval of Certification of Construction Report**

Dear Mr. Marion:

The Department has completed the review of the report titled "Report of Construction, February 2013 – March 2013, North Cell Landfill Gas Construction for Closure, Sequence 1A." The report was dated May 23, 2013 and received by the Department on May 28, 2013. The report and DEP Form 62-701.900(2) were signed and sealed by Mr. Junos Reed, P.E., of Volusia County.

In the Report, the existing conditions described on sheet 00LFG-01 dated May 23, 2013 do not match the existing conditions outlined in Attachment G, LFG Management Master Plan and North Cell Class I Landfill, submitted with the permit renewal application on December 28, 2012. During discussions with Junos Reed, P.E., he concluded that the LFG Master Plan had missed a construction event which occurred between the time the permit application was being written and the time the permit application was submitted. He said the existing conditions noted in this subject report were accurate, although missing a few well locations. We discussed how to address the discrepancies in the existing conditions. Mr. Reed indicated that the county would be reevaluating the LFG Master Plan in the near future prior to the next LFG construction event in November 2013. At that time, the county plans on submitting a permit modification to clear up the discrepancies in the existing conditions and to submit a revised LFG Master Plan.

Therefore, based upon the Report, further discussions with Junos Reed, P.E., and the signed and sealed certification, the Department concurs that the North Cell gas collection system construction for closure, sequence 1A has been completed and is substantially consistent with the intent, plans, and specifications.
