I apologize for the delay. Thank you for contracting the Florida Department of Environmental Protection (DEP) regarding the Waste Tire Collector Registration for Florida Tire Terminal. Per your request, the Waste Tire Collector Registration "Business Name" has been updated from Florida Tire Terminal to Central Florida Tire Terminal, Inc. Please note your new WACS ID #, 94452 for future correspondence. It will be the same as your WACS ID # for the Waste Tire Processing Facility located at the same address.

Additionally, I have updated the plate number on the 2001 Ford truck to # 304PKB and added the 2003 Ford truck, plate # M101LH, per your request. Per our discussion, I will apply the \$35.00 payment towards the additional decal request, since the company overpaid on their Waste Tire Collector Registration fees for 2013, accidentally while applying a second time through the online registration portal. 
