## Dear Mr. Contestabile:

Your application for permit, DEP File Number 0287891-002-WT-02, is considered complete as of November 21, 2013. The original permit application was dated October 6, 2013 and received October 9, 2013. We will make every effort to issue our final agency action as quickly as possible. In the meantime, if you have any questions, please feel free to contact me by phone or e-mail.

The Department has reviewed the signed and sealed response to the first request for additional information, dated November 26, 2013 and received via email. The email included a third party quote of \$50 per ton for the loading, hauling and disposal of all whole waste tires and processed waste tires from the facility. Based upon a maximum amount of waste tires on site at any one time of 825 tons, the closing cost is therefore estimated at \$41,250. The cost estimate is approved by the Department.

The most recent document received by the Department to demonstrate financial assurance was approved on September 11, 2013 for the amount of \$43,779.12. Therefore, no further action is required. Please note, this communication is **not** authorization to decrease that amount in the financial instrument; contact Susan Eldredge, FDEP Solid Waste Section, MS-4565, 2600 Blair Stone Road, Tallahassee, Florida 32399 for authorization to decrease.
