The Department acknowledges receipt of your notification of intent to operate Mobile Waste Tire Processing Equipment under General Permit Number WT56-269703. This letter authorizes the operation of the Mobile Equipment described in your application. The equipment shall be operated in accordance with the provisions of the Florida Administrative Code Rule 62-711.801.

The General Permit is subject to the general conditions of the Florida Administrative Code Rules 17-4.510 through 17-4.540 and the following specific conditions:

- 1) The mobile equipment shall operate at any one site for less than 120 days or shall obtain a Waste Tire Processing Facility Permit.
- 2) All processed tires and residuals shall be removed from the site within 30 days after the completion of operations.
- 3) The owner or operator of the mobile equipment shall report to the Department each January, April, July, and October describing each site at which the equipment was operated during the preceding three months. DEP form 62-711.900(2) shall be used for such reports.
- 4) Authorization to operate mobile equipment under a General Permit is suspended when the requirements of that General Permit are not fulfilled.
- 5) A General Permit for Mobile Equipment is a one year permit.
