This letter is to acknowledge receipt of the updated cost estimates dated September 16, 2013 (received September 18, 2013) as Attachment J of the Operations Permit Renewal Application, prepared by Sarasota County Solid Waste Department, for the operation and long term care of the Sarasota County Central County Solid Waste Disposal Complex. This estimate provides a reduced closing cost by removing costs associated with previously closed Phase I. The closing cost for Phase II and the total area for long term care of 118 acres is included in the updated cost estimates. The recalculated estimate(s) were submitted to comply with Rule 62-701.630(4)(a), Florida Administrative Code (F.A.C.). The following cost estimates received on September 18, 2013 are <u>APPROVED for 2013 and 2014</u>:

Closing – \$19,811,538.91 (Phase II) Annual Long-term care – \$664,256.34 (118 acres) Total Long-term care – \$19,927,690.20 for 30 years

The official date of final and temporary closure of Phase I for the facility is June 7, 2013.

The next annual updated inflation-adjusted estimate is due between January 1 and March 1, 2015.
