Volusia County received an email requesting the status with respect to responding to the Department's May 2, 2014 RAI. It appears that the issue related to the Department's concern raised in the RAI related to the ERP has been resolved as

per Deb Laisure's (DEP Central District Water Permitting) email below. As with any ERP application, the adequacy of the existing wet detention system relative to water quality treatment volume and permanent pool volume will be addressed. Since the pond serving the CCC and surrounding contributing areas was previously designed based on 90% runoff from all contributing areas, and the new CCC will only have 70% runoff, we are confident that the calculations to be prepared for the ERP modification application will demonstrate adequate water quality treatment volume and permanent pool volume within the existing wet detention system. Therefore, there should be no changes in the County's solid waste operations modification request and believe that the Department should no longer delay its review of the application.
