Explanation: Observed several areas located on the northern portion of the property where spilled or

leaked tar (solid waste) is visible on the ground. The Department has not issued any permits of other written authorization to store, process, or dispose of solid waste on the property. In one of the locations a deceased animal was observed stuck in the tar and presumed to have died as a result of contact with the material. 62-701.300(1)(a) Fla, Admin. Code., provides that "No person shall store, process, or dispose of solid waste

except at a permitted

solid waste management facility or a facility exempt from permitting under this chapter. 403.708(1), F.S. provides that "a person may not place or deposit any solid waste in or on the land or water located within the state except in a manner approved by the Department."

Corrective Action:

Within 30 day of receiving this report the responsible party shall remove all spilled. leaked, exposed tar and properly dispose of it at a class I landfill or other suitable disposal site. Transportation and disposal records for this related to this activity should be forwarded to the Department upon completion of the requested activity.
