On behalf of the Hardee County Solid Waste Department, ATKINS would like to submit the methane (landfill gas) readings at the Hardee County Landfill for the second quarter of 2014. The readings were collected by ATKINS personnel on June 12, 2014. The readings are presented on the enclosed Table 1.

Hardee County is in the process of expanding the existing landfill to the west as part of Phase II Section II Expansion Construction under FDEP Permit No. 38414-015-SC/01. Due to the expansion, gas probes GP-3, GP-4, GP-5 and GP-6 were abandoned and replaced with GP-3R, GP-4R, GP-5R, GP-5R, GP-6R, GP-7R and GP-8R.
