#### ORDER DISMISSING PETITION WITH LEAVE TO AMEND

On May 8, 2006, the Florida Department of Environmental Protection, Central District Office (Department), received the attached document from Petitioner South Apopka ACORN that could be considered a petition for administrative hearing (Petition). The Petition challenged the Department's decision to issue Permit Nos. SC48-0165969-010 and SO48-0165969-011 to Waste Management Inc. of Florida, for a Class III Landfill at its Keene Road South Facility.

Rule 28-106.201(2), Florida Administrative Code, and the notice provided to Petitioner explain what must be included in a petition for a formal administrative proceeding. The Petition considered in this order does not comply with the cited rule or with the notice provided to Petitioner. Therefore, the Petition does not contain sufficient information to enable the Department to determine whether a formal administrative proceeding should be held. Specifically, the Petition does not include the following:

- (a) A statement of when and how Petitioner received notice of the Department's decision:
- (b) A statement of how Petitioner's substantial interests are affected by the alleged final agency action;

- (c) A statement of all issues of material fact disputed by Petitioner or a statement that there are no disputed facts;
- (d) A concise statement of the ultimate facts alleged, including a statement of the specific facts that Petitioner contends warrant reversal or modification of the Department's proposed decision;
- (e) A statement of the specific rules or statutes that Petitioner contends require reversal or modification of the Department's proposed decision; and
- (f) A statement of the relief sought by Petitioner, stating precisely the action that Petitioner wants the Department to take with respect to its proposed decision.

In view of the above, the Petition must be dismissed as required by Rule 28-106.201(4), Florida Administrative Code.

#### IT IS THEREFORE ORDERED:

- A. The Petition is DISMISSED, without prejudice. The Petitioner is granted leave to file an amended petition providing the additional information listed above. Each person who wishes to participate as a party in the requested administrative hearing must be clearly identified, must provide the required information, and must state the name, address, and telephone number of the person signing the amended petition.
- B. Any amended petition must be filed (received) in the Office of General Counsel,
  Department of Environmental Protection, 3900 Commonwealth Boulevard, Mail Station 35,
  Tallahassee, Florida 32399-3000, by 5:00 p.m., on Monday, June 5, 2006.
- C. This order constitutes final agency action of the Department, unless a timely amended petition is filed in compliance with this order.

Any party to this proceeding has the right to seek judicial review of this order under Section 120.68, Florida Statutes, by the filing of a notice of appeal under Rules 9.110 and 9.190, Florida Rules of Appellate Procedure, with the clerk of the Department in the Office of General Counsel, 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-

3000, and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate district court of appeal. The notice of appeal must be filed within thirty days after the date this order is filed with the clerk of the Department.

#### INTENT TO ISSUE

The Department of Environmental Protection gives notice of its intent to issue a permit (copy of conditions attached) for the proposed project as detailed in the application specified above, for the reasons stated below.

The applicant, Waste Management, Inc. of Florida/R. David McConnell, applied on January 20, 2006, to the Department of Environmental Protection for a permit renewal to construct and operate the Keene Road South Landfill, Class III in Orange County, Florida.

The Department has permitting jurisdiction under Section 403.707(1), F.S. and Chapters 62-4, 62-701, and 62-711, F.A.C. The project is not exempt from permitting procedures. The Department has determined that a construction and operation permit is required for the proposed work.

Pursuant to Section 403.815, F.S., you are required to publish at your own expense the enclosed Notice of Proposed Agency Action. The notice shall be published one time only within 30 days in the legal ad section of a newspaper of general circulation in the area affected. For the purpose of this rule, "publication in a newspaper of general circulation in the area affected" means publication in a newspaper meeting the requirements of Sections 50.011 and 50.031, F.S., in the county where the activity is to take place. The failure of any person to file a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention (in a proceeding initiated by another party) will be only at the discretion of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, F.A.C.
