On October 1, 2014, Mr. Juan C. Guerra, P.E., of Guerra Development Corporation (GDC) submitted on your behalf a permit modification application for Friends Recycling, LLC – C&D Disposal and Recycling Facility (Facility). The application package included:

- Certification of Construction Completion Form 62-701.900(2) for construction of bottom floor of the remaining 2.87 acres of Cell 2A and the entire 4.4 acres of Cell 2B. The certification was signed and sealed on September 2, 2014 by Juan C. Guerra, P.E., of Guerra Development Corporation as the Engineer of Record.
- Topographic survey of the remaining 2.87 acres of Cell 2A and the entire 4.4 acres of Cell 2B. The survey was signed and sealed on September 2, 2014 by Juan C. Guerra, P.E., of Guerra Development Corporation as the Engineer of Record.

Based on the inspection on October 9, 2014, the construction of the floor of the remaining 2.87 acres of Cell 2A and the entire 4.4 acres of Cell 2B, as certified by the Professional Engineer of Record, Juan C. Guerra, P.E., of Guerra Development Corporation has been properly constructed consistent with the approved Operation Permit 42-0019600-008. The bottom elevation is no lower than 64 feet NGVD 1929.

This letter does not authorize the disposal of waste in the remaining 2.87 acres of Cell 2A or in Cell 2B. The authorization is being addressed in a permit modification that is being processed.

Cell 2 is 12.3 acres. Cells 2A, 2B and 2C are 7, 4.4 and 0.9 acres respectively. Cells 2B and 2C are permitted for disposal of clean debris. Cells 2A are sectioned into 1.36, 2.77 and 2.87 acres. Sections 2.77 and 1.36 acres were authorized to receive C&D debris on 3/3/2009 and 8/17/2011 respectively. A Certification of Construction Completion of floor bottom was submitted on October 2014 for the remaining 2.87 acres in Cell 2A and 4.4 acres in Cell 2B. The permit 0019600-008-SO-24 (issued 7/26/2013 and expire 6/19/2023) specifies cell bottom elevation shall not be lower than 64 feet NGVD 1929.

Most houses located west of the landfill have been hooked up to the City water supply and its potable wells became inactive have resulted in Friends C&D Facility to gain approximately 0.5 acres in Cell 2B for C&D debris (approximately 40 feet by 576 feet).
