Dear Mr. Partin:

This correspondence provides the annual report for Hillsborough County's Waste Tire Processing Facility for 2012, Permit No. 126787-004-WT/02. Provided is the amount of tire tonnage received at the County's Waste Tire Processing Facility (WTPF) and the amount of tires shredded.

The 2012 year at the County's WTPF began with an existing stored balance of 697.09 tons of whole tires. A total of 1,639.28 tons of tires were received in 2012, bringing the total tonnage to 2,336.37. Of the 2,336.37 tons of tires, 1,572.70 tons of tires were shredded, 79.41 tons of truck tires were disposed of at the landfill, 48.32 tons of rims were taken to an offsite recycling company, and 635.94 tons of whole tires remain onsite waiting to be processed.

The 2012 year also began with a total of 2,109.40 tons of stored shredded tires. A total of 1,106.29 tons of shredded tires were used as a fuel source at the County's Resource Recovery Facility, leaving a year end balance of 2,575.81 tons of stored shredded tires to be used for future landfill construction projects.
