I hope your morning is going well. When you get back to me with the fire safety inspection as it relates to the waste tire permit, can you also let me know what fire-fighting capability and considerations are taken for the landfill in general? I am referring to Rule 62-701.500(11)(e), Florida Administrative Code (F.A.C.), which simply requires adequate fire-fighting capability for controlling accidental burning of solid waste in the landfill. Fire protection can include procedures for notification of local fire agencies, as well as fire extinguishers in operators' trucks and/or throughout the facility that are inspected periodically by the Fire Marshal so that they are current and working.

For the above info request, you don't have to send me a formal report, just an e-mail letting me what measures are taken on-site.

- (3.) Q1 2015 Waste quantity reports I have just finished this, and was debating whether to bother sending it this quarter (which I usually do) because they are only required

annually since 2010. Last quarter when I submitted it, I got an email from DEP reminding me that they are only due annually.

(4.) Revised cost estimates and proof of funding for Class III (Due March 1 for Class III, but not due until September for Class I). **This must be a mistake!** I have no awareness of Class III changing to due as of March 1st. As a matter of fact, I have the approval letter from last year which states that it is due as of September 1st as usual.
